## **O R D E R**

**IA(C/ACT)/120/KOB/2024 IN IA(C/ACT)/161/KOB/2022 in CP(C/ACT)/3/KOB/2022**

This is an IA bearing No. 120/KOB/2024 filed by the Applicants (Respondents in IA(C/ACT)/161/KOB/2022 in CP(C/ACT)/3/KOB/2022) seeking directions to correct/typing mistake / error as to the cost sharing of the Independent Auditor and the name of the Counsels appearing for the Respondents in the order passed by this Tribunal, dated 26.06.2024 in IA(C/ACT)/161/KOB/2022.
