**ORDER**

The present petition has been filed U/s 241/ 242 of the Companies Act, 2013 alleging the oppression & mismanagement on the part of respondent nos.2 & 3.

It is alleged that these respondents have already sold the land belonging to the respondent no.1 company unauthorizedly against which three civil suits are filed by the petitioners in the year 2021 challenging their sale deeds and two FIRs have also been lodged against respondent no.3 & 4.

It is further alleged that the respondent no.2 & 3 have also forged the alleged resignation of the petitioners and both the petitioners are claiming 33% of the shareholding.

Ld. Authorized Representative on behalf of respondent no.1 to 5 is ready to accept the notice. Let the copy of the petition be supplied to the counsel opposite by the petitioner counsel. Ld. Authorized Representative for respondent no.1 to 5 is directed to file reply along with vakalatnama within three weeks with advance copy to the other side and thereafter, rejoinder be filed within two weeks.

In the meantime, respondent no.2 to 5 are directed to maintain status quo regarding the immovable property of respondent no.1 company.
