10. Appearance should be shared during the hearing in the Chat Box in the Cisco webex with item No. and for whom they are appearing
11. Parties/ counsels appearing physically should make attendance in the Register maintained in the court for the purpose
12. Note: Hybrid mode in the present context means court assisted hybrid hearings in case one party is physically present and the other party is appearing through Video Conference. This will continue till proper
