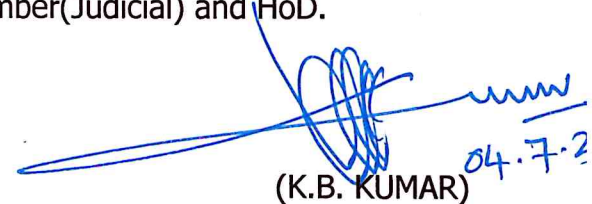
Sub: Non-listing of cases (CP/CA/IA/MA etc.,) for long time – regarding.
