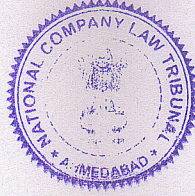

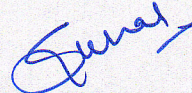
ORDER

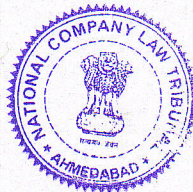
NOTICE

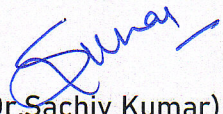
[Under Rule 28(3)]
