4 It is further requested to indicate in bold letters the next date of hearing of the main matter on the IA/MA.

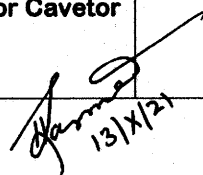
5 Matters for urgent hearing may be mentioned before the Bench.
