NOTICE

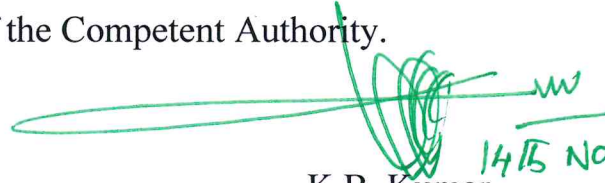
It is brought to the notice of all the concerned (Applicants/Petitioners/Respondents/Stakeholders) regarding the security code for e-filing of the documents:-

1. In many cases, Learned Advocates/IPs/IRPs/Liquidator/PCS/PCAs brought to the notice of the Registry that they are not getting the security code to e-file their documents in the e-filing portal. In this context, the following guidelines/points are brought to the notice of all the concerned.
 - a. The Petitioners should enter the correct details of the Respondents and their credentials at the time of filing Petition like mail id, Mobile number to get the security code for the Petitioners as well as Respondents.
 - b. As per the updated e-filing portal, Respondents may not be able to e-file their counters/Reply/Rejoinder etc., unless they get their security code either to their e-mail id or Mobile Number.
 - c. In case of already filed cases, the credentials like, copy of vakalatnama, mail id, Mobile Number, E-filing number, may be submitted to Registry for updating the same either by mail or in-person.

- d. The security code is not generated/given by Registry and it will be received by the respective mail ids/mobile Number of the concerned.
 - e. If you are not getting the security code, despite of entering correct mail id/Phone Number, then please check once the spam folder and click the option "re-send security code".
2. It is once again informed that at the time of filing of the cases, all the concerned should feed the details of mail id, mobile number etc., to get the security code.
 3. Even after up-dating all the details in the portal, if the concerned do not get the security code, the matter may be brought to the notice of Registry by sending mail to registrar-hyd@nclt.gov.in
