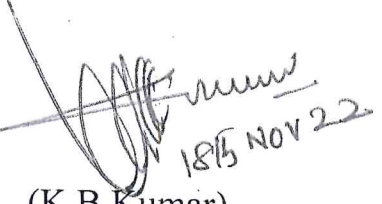
[Service of a copy of the Application filed under Section 7&9 of IBC]
