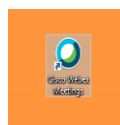
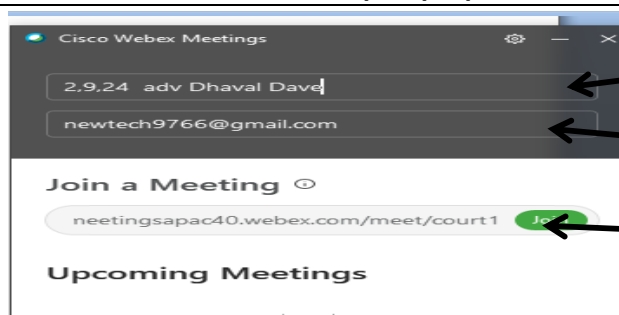

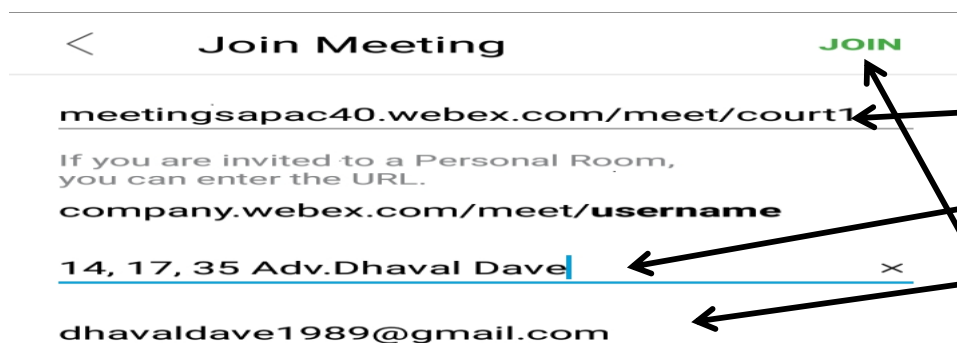

5 Matters for urgent hearing may be mentioned before the Bench.

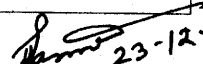
