ORDER

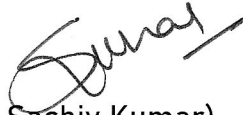
It is informed that by a notice bearing No.NCLT/AHM/NOTICE/1751/2023 dated 10th September,2023, (by affixing on notice board of Tribunal and uploading on e-portal of e-filing) sufficient time was granted to all concerned parties/Advocates to rectify/remove the defects in respect of 42 applications/petitions which were filed in the Tribunal as per Appendix 'A' within a period of 07 (Seven) days from the date of said notice as a last chance failing which all these cases will be dealt with for passing suitable order under Rule 28(3) of the NCLT Rules, 2016.
