



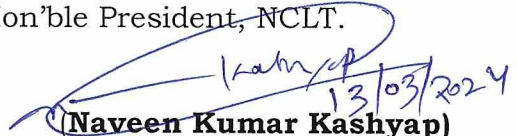

ORDER

1. National Company Law Tribunal (NCLT) will be holding a joint Colloquium with Ministry of Corporate Affairs (MCA), Insolvency Bankruptcy Board of India (IBBI) and National E-Governance Service Ltd. (NeSL) from 15th March 2024 to 17th March 2024.
