



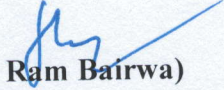

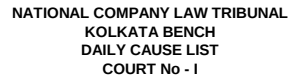
Sitting of the NCLT Benches for the period 1.2.2022 to 11.2.2022
PROCEEDINGS
