





**ORDER**

1. National Company Law Tribunal (NCLT) will be holding a joint Colloquium with Ministry of Corporate Affairs (MCA), Insolvency Bankruptcy Board of India (IBBI) and National E-Governance Service Ltd. (NeSL) from 15<sup>th</sup> March 2024 to 17<sup>th</sup> March 2024.
2. In view of the proposed Colloquium it is ordered :
  - (a) The matters listed for 15<sup>th</sup> March 2024 be re-notified at *all Benches of NCLT, whose members are participating in such joint Colloquium.*

  - (c) It is to be clarified that in case Hon'ble Member at any of the Bench is not participating in such joint Colloquium, she/he would continue to hold her/his court as usual.
