PROCEEDINGS

1. Reference order No. 10/03/2021-NCLT dated 31.12.2021 and No. 10/03/2022-NCLT dated 09.01.2022.
2. Due to sudden increase of Covid 19 cases due to Omicron variant and in order to sanitise the office premises of various Benches, on account of a few Officers/staff reporting Covid Positive and Covid like symptoms due to proximity or contact there is a need to adjust the working of the NCLT benches Pan India to safeguard all concerned persons.
3. The present mode of virtual hearing and e-filing will continue as per the earlier notification dated 31.12.2021 and 09.01.2022.
