NOTICE

I am directed to refer to the detailed SOPs issued by the Hon'ble Principal Bench, NCLT, New Delhi, dated 18.12.2021 and accordingly, in compliance of the same this is for the information of all concerned Advocates/Chartered Accountants/Authorized Representatives/Parties and party in person etc., that all the proceedings in NCLT, Chandigarh Bench shall be heard through physical mode, strictly complying with the guidelines as mentioned in the SOP *ibid*, and the instructions/guidelines issued by the Central Government/State Government with respect to COVID-19 shall be strictly followed during the physical hearing and other physical activities in the Court premises. Preferably only the parties concerned in the ongoing matter and parties of the next case should be present in the Court room. In no case more than 10 persons should be available in the Court room.

However, in cases where the concerned parties/counsels/authorized representatives desired the matter to be heard through Video Conferencing (in short 'VC') mode; the party/Advocate/authorized representative concerned shall make such a request in the **Telegram Group App** created for the purpose at Mobile No. 9988403037 namely 'NCLT_ChD_VC'. The following shall be ensured by the party making the request for VC:-

- i. The concerned counsel/party/authorized representative shall make the request for VC writing with correct details of the **Case Number, Date of Hearing, Title of the Case** in the above said Telegram Group;
- ii. The request so made for the VC hearing must reach at least TWO DAYS before the date of hearing i.e. if the date of hearing is 05.01.2022, the request must reach in the Telegram Group on 03.01.2022 before 12:00 Noon (the term TWO DAYS mentioned here shall mean TWO WORKING DAYS), except urgent hearing;
- iii. The request for the VC hearing as above shall be made by the concerned counsel for the party with an affirmation that all the other parties to the case

have been duly intimated about such request and none of the concerned parties to the case have any objection to such VC hearing and all the parties have consented for the same.

- iv. The request for the VC hearing shall be considered and the decision in this regard shall only be communicated in the relevant Cause List of the date i.e. to say no formal communication of acceptance or rejection of such request for VC hearing shall be made to the concerned counsels or authorized representatives or parties nor any query in this regard shall be entertained.
- v. All the parties to be heard through VC hearing shall be heard in the end after taking up of all the cases of physical hearing. The same shall also be reflected accordingly, in the Cause List.
- vi. The decision to accede to the request for the VC hearing shall be of the Competent Authority and the same shall be final and no request shall be entertained thereafter, contrary to the same.

The above instructions are issued for the smooth functioning of the NCLT Chandigarh Bench and for maximum convenience to the counsels/authorized representatives and the parties concerned. The above instructions have to be strictly followed w.e.f. 05.01.2022.

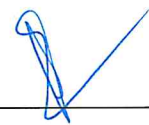

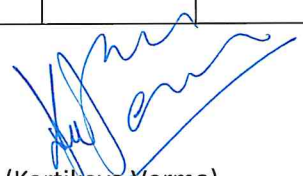
