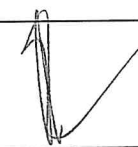

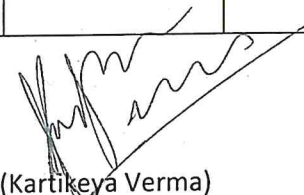

OFFICE CIRCULAR

In the light of the appointment of New Members in NCLT and removal of Additional Benches from the NCLT Chandigarh, it has been decided by the Competent Authority that NCLT Chandigarh Bench shall function only in Physical Mode from 14.12.2022(Wednesday), except in case of Constitution of a Special Bench consisting of a Member from outstation wherein the hearing shall be held through Video Conferencing only due to compelling circumstances.

Now therefore, it is hereby explicitly made clear that except for the above exception there shall be no hearings henceforth through VC Mode (Video Conferencing), hence no request be made by any concerned to allow or to permit the hearing through Video Conferencing as the same shall not be exceeded to. The physical hearing as above said shall start from 14.12.2022 and all the parties concerned shall comply with the following instructions:-

1. That not more than 4 Advocates including the Senior Advocate, if any shall appear during the arguments in the Court Room for each party respectively.
2. That the Counsels/Advocates for the serial No. next to the hearing going on, shall wait in the Court Room itself in the specified place having the sitting arrangement.
3. That the Counsels who have completed their arguments shall leave the Court Room promptly making place for the Counsels of the next item in the serial number and the Counsels waiting in the sitting area shall vacate entire sitting zone making place for the Counsels of the next serial number to take place in the Court Room.
4. That the above instructions make it clear that at any given time Counsels for not more than two item Nos. for hearing shall be present in the Court

Room reducing the physical interaction and proximity as much as possible.

5. That all the other Counsels waiting for their item shall keep track on the Digital Display Board placed in the Lobby/Waiting Area and shall comply with the instructions *ibid*.
6. That adjournments shall not be granted in ordinary course.
7. That no mentioning shall be entertained unless the same has been informed and a formal request made a day before to the Registrar/Court Officer in writing mentioning therein the request of urgency leading to such mentioning. However, in very exceptional circumstances the Bench may allow mentioning otherwise when the cause of action has arose on the very date of mentioning itself or the same has come to the knowledge of the parties/Counsels on the date of mentioning itself.
8. That the Counsels/parties concerned, after the completion of their matter in the Court shall promptly leave the Court premises and shall not gather in the Lobby as the same would amount to chaos and physical proximity which is to be avoided.
9. That the parties concerned shall not park their vehicle inside the Building Complex and shall park their vehicles in the designated parking as per the Municipal Corporation.

The above instructions are being issued with the approval of the Competent Authority for more smooth and steady convening of the physical hearings in the NCLT Chandigarh Bench. All the concerned are requested to strictly comply with the said instructions.
