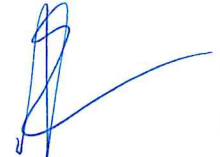

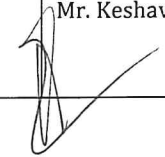

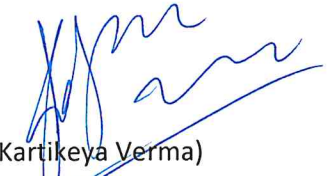

This is to bring to the notice of all concerned learned Advocates, Chartered Accountants, Company Secretaries and other parties concerned that the process of mandatory e-filing of the pleadings was implemented from June, 2020.
