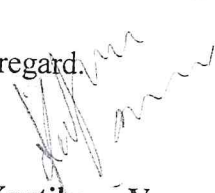
OFFICE ORDER

In the light of the present Covid-19 situation in Chandigarh and country as a whole and also in the light of the directions issued by the Hon'ble Principal Bench dated 15th January, 2022, it has been decided to defer the following until further order.

- 1) The regular Cause List shall be adjourned as it is to a future date as mentioned against each item in the REMARKS column of the uploaded Cause List.
- 2) The Registry shall remain closed for any form of physical filing, that is to say no document shall be physically filed. However in matters of urgency, the matter shall be filed only through e-portal and the same shall be communicated to the Registrar NCLT Chandigarh, explaining the reasons of urgency, through e mail along with the soft copy of the application desired to be heard. The same shall be taken up in the hearing at the earliest after approval from the Hon'ble HOD, NCLT, Chandigarh. The decision of the Hon'ble HOD, NCLT, Chandigarh shall be final and no further communication shall be entertained thereafter on the issue.
- 3) No application for certified copy shall be entertained. No notices shall be issued except in urgent cases taken up and the same shall be collected only through the reception and no advocate or person concerned shall visit the office to collect the notices or copy of the orders as the case may be.
- 4) No inspection of records shall be allowed.

These protocol shall be effective till the normalisation of the Covid-19 situation in Chandigarh and appropriate orders shall be issued accordingly thereafter. These instructions are with the intent to minimise the physical interaction of the individuals both inside and outside the NCLT, Chandigarh. Co-operation of the NCLT Bar, Chandigarh, is solicited.

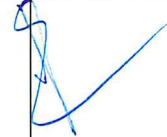

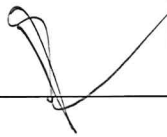

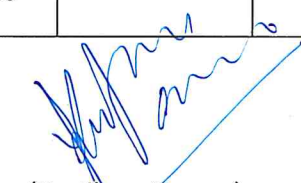
