Parties shall keep their Audio muted & Video closed till their matter is called out.</p> <p>8. Parties should be ready with requisite infrastructure to share the documents on-line during the hearing.</p> <p>9. Parties should be ready to share on-line, the Judgments / Citations sought to be relied upon.</p> <p>10. Appearance should be shared during the hearing in the Chat Box in the Cisco webex with item No. and for whom they are appearing.</p> <p>11.
