Subject: Guidelines for Mentioning Cases in the Courtroom

This is to bring to the attention of all concerned parties, advocates, and authorized representatives that the following guidelines shall be strictly adhered for the mentioning of cases in the courtroom:

1. **Intimation to Opposite Counsel:** Mentioning shall only be permitted with due intimation to the opposite counsel. This is strictly restricted to requests for adjournments or matters of an urgent nature.
2. **Out-of-Turn Hearings:** No mentioning will be allowed for out of turn hearing of cases on the daily cause list.
3. **Procedure for Mentioning:** The list of matters to be mentioned must be provided to the Court Officer before the bench assembles. This must be submitted through a formal mentioning slip or via the designated chat box, and the matters will be called out accordingly.
4. **Timing of Mentioning:** Mentioning will be allowed only at two stages, once when the Court starts and thereafter when the Court rises.
