Although all efforts have been made to give accurate information in the Cause List, the possibility of an inadvertent error cannot be ruled out and regretted, if any.

All the concerned professionals, learned Advocates are requested to connect themselves with the VC.

As soon as any Guest joins the VC room, the guest is requested to mute the Mic & Video in his Laptop/Desktop. When AA permits/asks the guest to submit his/her presentation as per order of priority, that particular guest alone should join the proceedings by unmuting Mic and Video.

All the concerned professionals, learned advocates and litigants are requested to be in formal dress while addressing in VC. All are requested to ensure that the submission be made from calm and quite place, so that the Bench could hear the submissions without being distracted by noise impending from surroundings.
