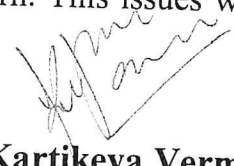

### **OFFICE ORDER**

In the light of the present Covid-19 situation in Chandigarh and country as a whole and also in the light of the positive cases reported in NCLT, Chandigarh itself and accordingly in compliance of instructions issued by the Govt. of India, the staff strength has been brought down to 50%. Further, also in compliance of the Hon'ble NCLT, New Delhi, Order No.10/03/2021-NCLT dated 09.01.2022 it has been decided to defer the following until further order.

1. The counsels/ parties concerns are requested to minimize physical filing in the Registry, to minimize the interaction with the office staff. However, in matters of urgency, the matter shall be filed through e-portal and also in physical copy. The same shall be communicated to the Registrar, NCLT, Chandigarh, explaining the urgency. The same shall be taken up in the hearing at the earliest after approval from the HOD, NCLT.
2. No application for certified copy shall be entertained. The notices shall be provided only through the reception and no advocate or person concerned shall visit the office to collect the notices or copy of the orders as the case may be, as directed by the Hon'ble Bench.
3. All compliance as directed by the Hon'ble Bench are to be filed through the e-filing portal only and not in physical form, until further order.
4. No inspection of records shall be allowed until further order in this regard.

These protocol shall be effective till the normalisation of the Covid-19 situation in Chandigarh and appropriate orders shall be issued accordingly thereafter. These instructions are with the intent to minimise the physical interaction of the individuals both inside and outside the NCLT Chandigarh. This issues with the approval of the competent authority in this regard.

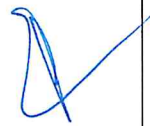

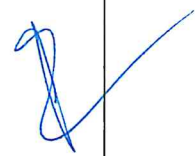
