9. Parties should be ready to share on-line, the Judgments / Citations sought to be relied upon.

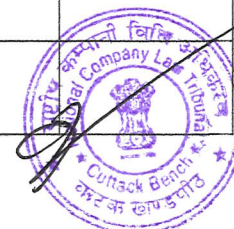
10. Appearance should be shared during the hearing in the Chat Box in the Cisco Webex with item No. and for whom they are appearing.

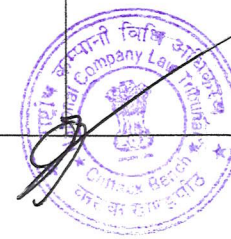

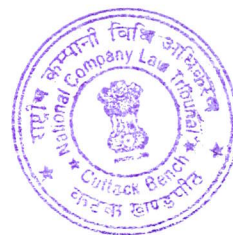
