8. Parties should be ready with requisite infrastructure to share the documents on-line during the hearing.

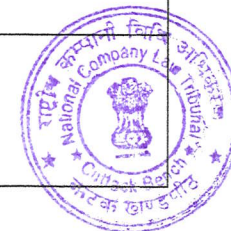

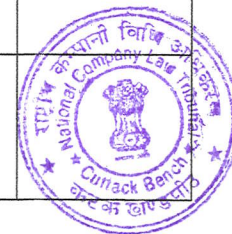

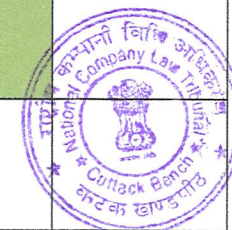
