10. Appearance should be shared during the hearing in the Chat Box in the Cisco webex with item No. and for whom they are appearing.

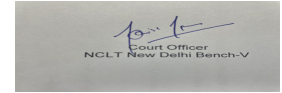
11. Parties/Counsels appearing physically should record their attendance in the Register maintained in the Court for the purpose.
