**9. Parties should be ready to share on-line, the Judgments / Citations sought to be relied upon.**

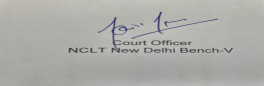
**10. Appearance should be shared during the hearing in the Chat Box in the Cisco webex with item No. and for whom they are appearing.**
