This will continue till proper hybrid system is set up for which consultation is in progress with the Ministry of Corporate Affairs and Stakeholders.

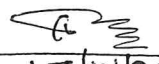

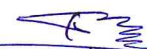

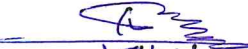
