10. Appearance should be shared during the hearing in the Chat Box in the Cisco webex with item No. and for whom they are appearing.

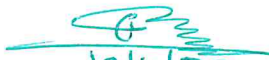
11. Parties/ counsels appearing physically should make attendance in The Register maintained in the court for the purpose.

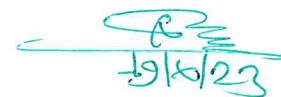
