



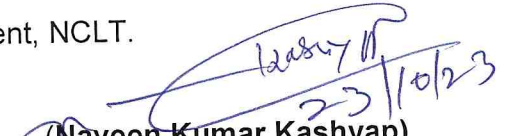

ORDER
