2. Hon'ble Member (T) Shri K.K. Singh

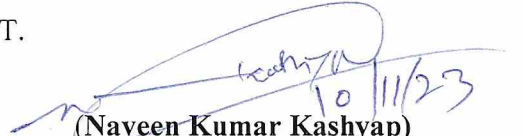
