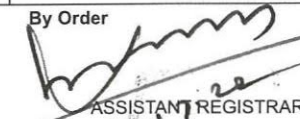

This issues with the approval of Hon'ble President, NCLT.

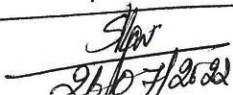
