2. Hon'ble Member (T) Ms. Anu Jagmohan Singh

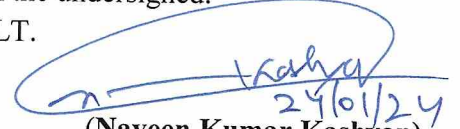
