2. Hon'ble Member (T) Ms. Anu Jagmohan Singh

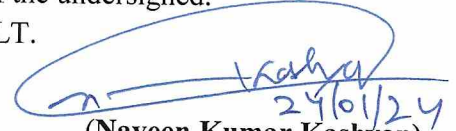

7. Parties should be ready with requisite infrastructure to share the documents on-line during the hearing.

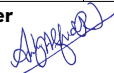
