Sub: Repairing of NCLT court premises and functoning of Courts.

Respected Sir,

This is to submit before you that NCLT, Kolkata Bench is housed in a very old heritage building in Kolkata.

Portions of 1st Floor of the building particularly in the Registry and in the staircase & in some parts of the floor in Court-I has suddenly caved in. As a result it has become a life risk for the officials and staff of the Tribunal to work there. Thereafter CPWD Engineers were contacted for making an immediate repairing on emergency basis. They have started the repairing, the portion of Court-I has mostly been repaired however the damaged parts of Court-II has only been partly repaired.

Thus, Bench-I may function from tomorrow physically. However, considering the condition of Bench-II it cannot function from the Court Room itself.

However, Hon'ble Member (T) & HoD alongwith the other Hon'ble Members, have discussed the gravity of the situation and decided that since the condition of Court-II is not good enough to conduct the physical hearing from the Court room, as it may not be safe for the Hon'ble Members as well as the Advocates & Professionals, therefore it will be wise to conduct Virtual hearing of cases for Court II only, from the Office Chamber of the respective Hon'ble Members, from tomorrow till 25th of May, 2022. From 26th May onwards, this Tribunal will be having vacation, and CPWD has informed that they will be resuming the repairing job on and from 26th May, 2022.

The entire repairing job will be completed within 08-10 days as intimated by the CPWD, and such period will be within the period of vacation, which is continued till 05th of June, 2022. After that the entire building will be safe as per their version to conduct physical hearing from both the Courts.
