11. Parties/ Counsels appearing physically should make attendance in The Register maintained in the court for the purpose.

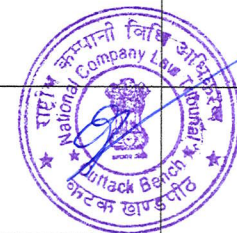

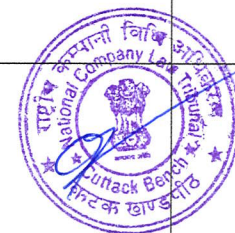
