10. Appearance should be shared during the hearing in the Chat Box in the Cisco Webex with item No. and for whom they are appearing.

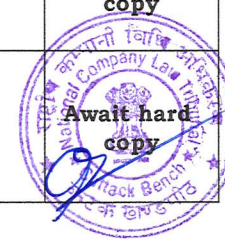
