- 6. Parties are requested to test the Audio & Video Quality of their system before hearing and switch on their camera only at the time of appearance.
- 7. Parties shall keep their Audio muted & Video closed till their matter is called out.
- 8. While appearing through virtual mode Counsels/ parties ensure that the video is on & camera is working properly when the matter is taken up. There should be no background noise/disturbances, refrain from appearing in a moving vehicle.
- 9. Counsels should appear in appropriate dress.
- 10. Parties should be ready with requisite infrastructure to share the documents on-line during the hearing.
- 11. Parties should be ready to share on-line, the Judgments / Citations sought to be relied upon.
- 12. Appearance should be shared during the hearing in the Chat Box in the Cisco web-ex with item No. and for whom they are appearing.
