

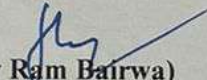

PROCEEDINGS

1. In Continuation of this office order No. 10/03/2021-NCLT dated 31.12.2021, 09.01.2022 & office order No. 10/03/2022-NCLT dated 15.1.2022 and as directed by Hon'ble President NCLT, the existing system of hearing of cases in all NCLT benches Pan India shall continue till 11.2.2022.
