### ORDER UNDER RULE 28(4) OF THE NCLT RULES, 2016

Ref: Notice dated 08.04.2026 issued under Rule 28(2)

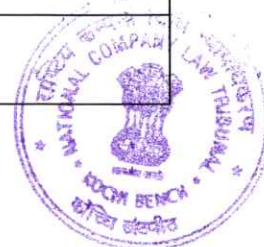
