ORDER

[Under Rule 28(4)]

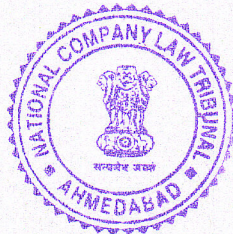
NOTICE
