1 IA(IBC)/192/KOB/2021 IN TIBA/07/KOB/2019

This IA has been filed under Section 44(2) of IBC Liquidation Process Regulation 2016 by the Liquidator seeking extension of the Liquidation period of Sargam Builders Pvt Ltd for another six months from 16.12.2021 to 15.06.2022.

Learned Liquidator Shri Jasin Jose appeared in person through VC.

The liquidator submitted that lot of litigations have taken place against the CIRP/ liquidation process in the NCLAT as well as in the Hon'ble Supreme Court. He also pointed out that CD was not co-operating and abused him on each time when he requests for details and documents with regard to the liquidation process, stating that any further action of liquidation process can be done only after disposal of MA/207/KOB/2020. This Tribunal dismissed the above MA on 20.09.2021 with costs of Rs.25,000/-, with direction to remit the amount to the Liquidator's account within two weeks from the date of Order, but still the same has not been complied with by the Suspended Managing Director of the CD.

During the hearing, the learned liquidator stated that he will not collect his fees for the period when the litigations were taken place. After hearing the learned Liquidator through VC and on perusal of records, we are of the considered opinion that the prayer of the Liquidator for extension of the period of liquidation for another six months from 16.12.2021 to 15.06.2022 be allowed. Hence IA(IBC)/192/KOB/2021 stands allowed.

The liquidator is directed to complete the Liquidation Process on or before 15.06.2022. He is also directed to discharge his powers and duties as specified under Section 35 to 41 of IBC, 2016 and meticulously adhere to the Rules and Regulations issued by IBBI in this regard from time to time.

2 MA(IBC)/36/KOB/2021 IN IBA/258/CB/2019
