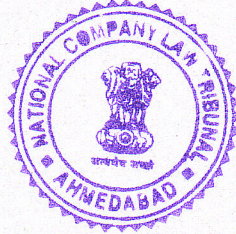


**ORDER**  
[Under Rule 28(4)]

It is informed that by issuing notice bearing No.NCLT/AHM/NOTICE/2024/2311 dated 30.08.2024 (by affixing on notice board of Tribunal and uploading on e-portal of e-filing) sufficient time was granted to all concerned parties/Advocates to rectify/remove the defects in the petitions/applications within a period of 07 (Seven) days from the date of said notice as a last chance failing which all these cases will be dealt with for passing suitable order under Rule 28(4) of the NCLT Rules, 2016.
