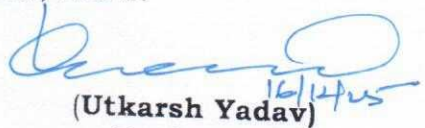
1. The National Company Law Tribunal will be observing court from 22nd December to 31st December 2025.
