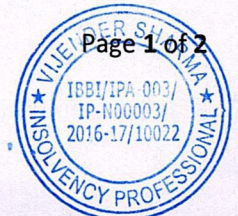

The said notice shall be –

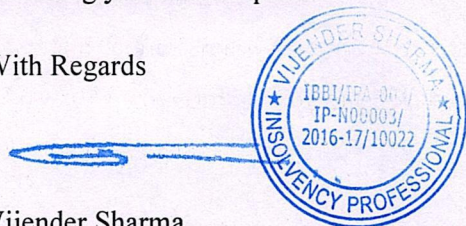
- published in English and one Vernacular Language newspaper which is in circulation in the State where the debtor resides;
