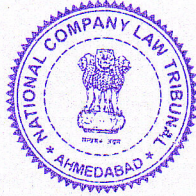

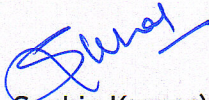
ORDER
(Rule 28(4))

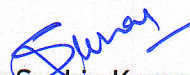
[Under Rule 28(3)]

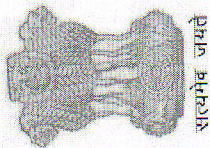

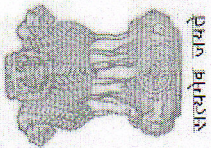

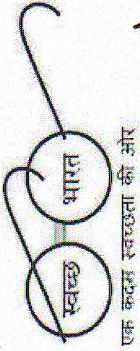
