Dear Sir,

Please be apprised that the Hon'ble Adjudicating Authority, New Delhi, Bench III has passed the order dated 28.02.2024 u/s 100 of the Insolvency and Bankruptcy Code, 2016 ("**Code**") for initiation of insolvency resolution process in the matter of Personal Guarantor, Mr. Arvind Dham (PAN no. AAUPD0970A), of **M/s Stride Autoparts Limited** and directed the undersigned to proceed further in accordance with the provisions of the Code and IBBI (Insolvency Resolution Process for Personal Guarantors to Corporate Debtors) Regulations, 2019. A copy of the order dated 28.02.2024 is attached herewith for your reference and record as **Annexure 1**.

In accordance with Section 102 (1) of the Code, a public notice must be issued within seven days of passing of the order u/s 100 of the Code, inviting claims from all creditors within 21 days of such issue. The notice shall include details of the present order, particulars of the Resolution Professional with whom the claims have to be registered and the last date for the submission of the claims. The said notice shall be –

- published in at least one English and one Vernacular Language newspaper which is in circulation in the State where the debtor resides.
- affixed in the premises of the Adjudicating Authority; and
- placed on the website of the Adjudicating Authority.



The required Public Notice has accordingly been issued/published in the Business Standard Newspaper (English -All editions Pan India) and Rastriya Sahara (Hindi – Delhi NCR edition) on 02.03.2024. The copies of the public notice given in the said newspapers are annexed herewith as **Annexure 2 (Colly.)**.

Pursuant to the above, the undersigned hereby requests your good office to do the needful for affixing the said public notices in the premises of this Adjudicating Authority and place the same on the website of the Adjudicating Authority in accordance with Section 102 (3) (b & c) of the Code.
