This is in reference to the Order passed by Hon'ble NCLT, New Delhi (Court II) dated 27.04.2026, initiating the Bankruptcy Process against **Mr Akshar Kuchroo** (Personal Guarantor of the corporate debtor (Samprash Foods Limited) under section 121 r/w 123 of Insolvency and Bankruptcy Code, 2016. Further, the undersigned i.e., Megha Agrawal having IBBI registration number - IBBI/IPA-001/IP-P01456/2018-19/12272, who was appointed as the Bankruptcy Trustee of the Personal guarantor vide order dated 27.04.2026 shall carry actions in terms with the provisions of the Code.

It may further be noted that in accordance with stipulation contained in Section 130, a public notice shall be issued within Ten days of passing of order under sec 121 inviting claims and the same shall be placed on the website and affixed in the premises of the adjudicating authority, whereby, the relevant Sub-section is enclosed for your kind perusal: -

1) *The Adjudicating Authority shall issue a public notice within Ten days of passing the order under section 121 inviting claims from all creditors within seven days of such issue*

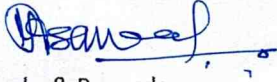
2) *The notice shall be -*

- (a) published in at least one English and one vernacular newspaper which is in circulation in the state where the debtor resides;*
- (b) affixed in the premises of the Adjudicating Authority; and*
- (c) placed on the website of the Adjudicating Authority.*

A Public Announcement has been made in the Financial Express and Navkal Mumbai Edition inviting claims from the creditors on 25.05.2026. The last date of filing claim is 01.06.2026. A copy of the Public Announcement is annexed here for your reference.
