1. There shall be a Special Bench at NCLT Chandigarh for pronouncement of orders. The Special Bench shall comprise of:

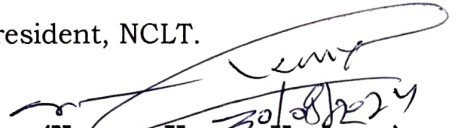
