Special Bench at NCLT New Delhi- Court no. VI (Second Half)

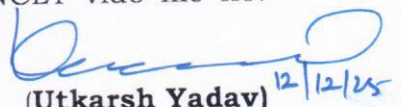
1. Hon'ble Member (J) Shri Mahendra Khandelwal
