Notice is hereby given that the Hon'ble National Law Tribunal, New Delhi, Bench II (NCLT), in (IB) No. 97(ND)/2022 filed by Indiabulls Housing Finance Ltd under Section 95 of the IBC, 2016 against the Personal Guarantor named hereinabove, admitted the Petition on 22.04.2024. Subsequently, the Hon'ble NCLT replaced the previous Resolution Professional and appointed Shiv Nandan Sharma as the new Resolution Professional by an order dated 27.05.2024 (received by the undersigned on 3rd June 2024 from Hon'ble NCLT) passed in IA 2148/2024 in (IB)-97/ND/2022. The Hon'ble NCLT directed that the newly appointed RP shall discharge his functions in accordance with the Hon'ble NCLT's order dated 22.04.2024, afresh. Consequently, this Public Notice is being republished in the same newspapers (except Chandigarh Editions) where the previous Resolution Professional had initially published the Notice.
